State Commission for Scheduled Castes and Scheduled Tribes Act, 2003 (Act 9 of 2003 and Amendment Act No.13 of 2006) the Government hereby nominate Sri Karem Sivajee, as the Chairman to the re-constituted A.P. State Commission for Scheduled Castes/ Scheduled Tribes.

2. The term of the Chairman will be for a period of (3) three years from the date of taking over charge or attaining the age of sixty five (65) years, whichever is earlier.
