ORDER:

Sri S.Satyanarayana Raju, Divisional Panchayat Officer, Kovvur, West Godavari District is hereby temporarily appointed by transfer on promotion under Rule 10(a) of Andhra Pradesh State & Subordinate Service Rules, 1996 to the post of District Panchayat Officer in the scale of pay of Rs.37100-91450/- plus usual allowances admissible under the rules in force from time to time.

2. On promotion as District Panchayat Officer, **Sri S. Satyanarayana Raju is posted as District Panchayat Officer, Vizianagaram District** in the existing vacancy.

3. The appointment order in para-1 above is subject to the following conditions:-

- (a) it is purely temporary and on an adhoc basis and shall not confer any right for regular appointment. He is liable to be reverted as Divisional Panchayat Officer at any time without notice and without assigning any reason thereof;
- (b) the appointment is subject to outcome of WPs/WAs/RPs/CAs/OAs etc., if any pending before the A.P. Administrative Tribunal/High Court or any other courts.

4. Sri S.Satyanarayana Raju should join the post of District Panchayat Officer, Vizianagaram District within fifteen (15) days from the date of receipt of this order. If he fails to join or evades joining by applying leave or otherwise, within the stipulated time, he shall forfeit all his rights both for the present and future for the post of District Panchayat Officer without any notice in terms of General Rule 11(b) of Andhra Pradesh State & Subordinate Service Rules, 1996 read with G.O.Ms.No.123, General Administration (Ser.D) Department, dated 14.03.2001.
