ORDER:

In the reference 1st read above, the erstwhile Government of Andhra Pradesh have issued comprehensive guidelines for implementation of Self Employment Schemes in all the Welfare Departments for 2013-14. In the reference 2nd read above, the erstwhile Government of Andhra Pradesh have also issued guidelines for implementation of Self Employment Scheme Rajiv Abhyudaya Yojana (RAY) in the Urban Areas by the BC Corporation. In the reference 3rd read above, Government have issued revised guidelines for implementation of Self Employment Scheme Rajiv Abhyudaya Yojana in the Urban Areas by the Telangana Backward Classes Cooperative Finance Corporation Ltd.

2. In the reference 4th read above, the Group of Ministers on Welfare with Ministers (Finance, BC Welfare & Tribal Welfare) under the chairmanship of Deputy Chief Minister (Education), Telangana State have made the recommendations in regard to Self Employment Schemes being implemented by Telangana Backward Classes Cooperative Finance Corporation Ltd., as follows:-

Sl.No.	Criterion	Existing Subsidy	Proposed Subsidy
1.	Subsidy for BC Corporation	50% the Unit cost limited to Rs.1.00 lakh	Unit cost upto Rs.1.00 Lakh – Subsidy 80% Unit cost Rs.1.00 Lakh – Rs.2.00 Lakhs - Subsidy 70% Unit cost above Rs.2.00 Lakhs Subsidy 60% limited to Rs.5.00 lakhs. Balance is bank loan.

3. Government, after careful examination of the matter, hereby order that the guidelines issued in the reference 3rd read above shall be followed during 2015-16 also for implementation of self employment / economic support schemes being implemented by the Telangana Backward Classes Cooperative Finance Corporation Ltd., subject to the following modification:

Unit cost	Subsidy
Upto Rs.1,00,000/-	80%
Unit cost Rs.1,00,000/- to Rs.2,00,000/-	70%
Unit cost Rs.2,00,000/- to Rs.10,00,000/-	60% or Rs.5.00 lakhs (whichever is less).

Government hereby approves the action plan for Telangana Backward Classes Cooperative Finance Corporation Ltd., for the year 2015-16 for implementation of Self Employment Scheme under Rajiv Abhyudaya Yojana in the Urban Areas. The details of District wise Action Plan 2015-16 is appended to this order. Government further orders that the above approval is subject to meeting the expenditure within the B.E. 2015-16.

5. The Managing Director of Telangana Backward Classes Cooperative Finance Corporation Ltd., concerned shall take necessary action accordingly.
